This correspondence constitutes official record of the first alteration of a "Request for Proposals for LAVTA Financial Auditing Services #2017-01" issued on December 19, 2016.

| 1. How long have the current auditors been performing the audit for the City? | The Livermore Amador Valley Transit Authority (LAVTA) is a Joint Powers Authority, with a Board of Directors comprised of officials from the Cities of Livermore, Dublin, and Pleasanton and the County of Alameda. The current auditors began with audit year 1996. |
| 2. How long have the current auditors been performing the audit for the City? | One week for interim with two auditors and one week for year end with two auditors. |
| 3. What were the prior audit fees by deliverable? | For FY16 (billed as of 12/8/16) CAFR \$20,025, TDA \$1,015, Prop 1B \$810, Measure B \$910, Measure BB \$910. |
| 4. Are there any new services requested in this RFP that were not included in the prior year audit fee? | Yes, in FY 16 we did not have a single audit while in FY 17 we will (not new). Additionally, we will be adding two new operating funds (rail, and on demand) so while not new services- something to be aware of. |
| 5. How many journal entries were proposed by the auditors? | 23 total, 4- reclassifying, and 19- adjusting |
| Were there any findings? | No findings |
| 6. Will your prior auditors be invited to bid? | Yes. |
| 7. Do you expect to have any retirement or replacement of key employees? | Yes. |
| 8. Is there anything specific that you are looking for with the successor auditors? | Please reference the Request for Proposals regarding information pertaining to scope of work and qualifications and evaluation factors. |

| 9. Do you expect to have a single audit this year? | Yes. |

| 10. Are there any significant third party service providers (e.g. claim third party administrator, billing services)? | Liability claim services; however all accounting is done inhouse. |
| 11. Is the Agency planning to issue any new debt? | No, and LAVTA does not currently have any debt. |
| 12. Are client prepared schedules available electronically? | Yes. |
| 13. Have you had an actuarial study performed for OPEB as required by GASB 45 in the last 2 years? | Yes. |
| 14. Have you had any major events, or anticipate any, under the course of the contract? | We are planning on going out to bid for our primary fixed route contract. We are creating a new type of service "ondemand", and we are helping start up the BART to ACE regional rail project. |
