#### 6. Chair Report

Esther Waltz updated the committee on the PAPCO sub-committee's Annual Paratransit Plan reviews for ACTC Measure BB funds. The sub-committee approved LAVTA's application. The next PAPCO meeting will take place in June.

# 10. Service Updates and Concerns

Carmen Rivera-Hendrickson reported an incident when she had exited a Route 3 bus due to the fumes she felt in the bus and made it hard for her to breathe. Christian Pereira responded that after the investigation process it was concluded these may have been fumes coming off of the high temperature exhaust caused by the Regen process that the buses have. Regen process captures the carbon that

is in the exhaust system and then cooks it at high heat. This produces lower carbon particulates that are passed through the exhaust.

Judy LaMarre reported that on Easter Sunday DAR got her to the church late.
