Action Requested

The Projects and Services Committee forwarded the recommendation to the Board of Directors to ratify the Tri-Valley Accessible Advisory Committee (TAAC) appointments with a request that the term end dates for the members are more staggered.

Background

The Tri-Valley Accessible Advisory Committee consists of community members who are appointed to represent their respective cities and Alameda County on accessibility issues facing senior and disabled residents on Wheels fixed route and Dial-A-Ride services. The TAAC also includes individuals representing public social service agencies. The TAAC is comprised of ten (10) representatives, five (5) alternates, and one (1) Alameda CTC Paratransit Advisory and Planning Committee (PAPCO) representative. The term for three of the 15 seats will expire on June 30, 2023 while the term of the other 12 seats (including two vacancies) will expire on June 30, 2022. These individuals include:

- Donna Singer Dublin Alternate
- Judith LaMarre Livermore Representative
- David Weir Livermore Representative
- Michael Balero Livermore Alternate
- Jeffrey Jacobsen Pleasanton Representative
- Herb Hastings Alameda County Representative
- Kulwant Singh Alameda County Alternate
- Diana Houghtaling Social Services Representative
- Amy Mauldin Social Services Representative
- Shay Roberson Social Services Representative

There are total of 13 representative and alternate seats available for terms starting on July 1, 2022 since the Pleasanton alternate and Social Services alternate seats are currently vacant.

Discussion

At the May Project & Services Committee meeting, Chair Josey and Director Haubert inquired about the timing of the reappointments and suggested staggering the rotation of openings to help with future recruitments. Under Section 3.3 of the TAAC Bylaws, it states, "the term of appointment of each committee member and alternate shall generally be for two (2) fiscal years, unless a one (1) year term is necessary to ensure continuity of membership

and avoid all appointments expiring at the same time." Given that 13 of the total 15 seats are up for appointments, this is an ideal time to stagger the term end dates.

LAVTA received 12 applications for the 13 open seats:

Dublin Representation – Two applications received for two open seats

- Connie Mack Current Dublin member
- Donna Singer Current Dublin alternate

Staff recommends that Ms. Mack continues as the Dublin representative with term expiring on June 2024 and Ms. Singer as the Dublin alternate with term expiring on June 2023.

Livermore Representation – Three applications received for three open seats

- Judith LaMarre Current Livermore representative
- David Weir Current Livermore representative
- Susan O'Neill New applicant and a Dial-A-Ride rider

Staff recommends that Ms. LaMarre and Mr. Weir continue as the Livermore representatives with term expiring on June 2024 and Ms. O'Neill becomes the Livermore alternate with term expiring on June 2023.

Pleasanton Representation – One application received for two open seats

• Sue Tuite – Sue used to be a TAAC member in the past

Staff recommends that Ms. Tuite become Pleasanton representative with term expiring on June 2024. Pleasanton alternate seat will remain vacant as not enough applications were received.

Alameda County Representation – Two applications received for two open seats

- Herb Hastings Current Alameda County member
- Kulwant Singh Current Alameda County alternate

Staff recommends that Mr. Hastings continues as the Alameda County representative with term expiring on June 2024 and Mr. Singh as the Alameda County alternate with term expiring on June 2023.

Social Services Representation – Four applications for four open seats

- Diana Houghtaling Current Social Services member
- Amy Mauldin Current Social Services member
- Shay Roberson Current Social Services member
- Zack Silva New applicant, City of Pleasanton Recreation Supervisor

Because Ms. Houghtaling preferred serving as an alternate, staff recommends reappointing Ms. Mauldin and Ms. Roberson and appointing Mr. Silva for the Social Services representative seats with term expiring on June 2024 and appointing Ms. Houghtaling for the Social Services alternate seat with term expiring on June 2023.

With the term of the alternates being reduced to one year, 7 of the 15 seats (excluding PAPCO representative) will be up for reappointments in 2023 while the remaining 8 seats will be up for reappointments in 2024 (see Attachment 1).

Recommendation

Staff recommends the Board of Directors ratify the TAAC appointments for terms starting on July 1, 2022.
