- 6. August Service Changes Update: 10R Detour**

Staff informed the committee on the implementation of a series of schedule changes on local, express and Rapid routes to align with the new BART schedule that took effect on August 12, 2024. Part of this service change was a temporary Route 10 detour by Meadowlark Dairy in Pleasanton. Staff stated that starting on September 9th Route 10 will resume its normal route in both directions. The only exception is that the bus will not go down on Old Stanley and the bus stop on WB First and Neal will be closed. Staff showed the newly proposed temporary bus stop on First Street on Google maps. Members provided their feedback on the proposed temporary bus stop and felt that the sidewalk is too narrow for the bus to be able to deploy the ramp in such a way that it can be accessed with wheelchairs. Staff will go out to the bus stop with a bus to test if there is enough space for the ramp to be deployed and used safely.

- 7. PAPCO Report**

Esther Waltz talked about the PAPCO/ParaTAC joint meeting on July 22nd. There was a presentation on the Alameda Countywide Transportation Plan for which the committee members provided their feedback.

- 8. Service Updates and Concerns**

Shawn Costello reported that on August 28th a Route 4 bus driver did not let him deboard the bus at his requested bus stop on Village Pkwy and Amador Valley. Staff to follow up.

Herb Hasting brought to the staff's attention that drivers still don't align the bus with the concrete pad on Route 8 EB First Street bus stop.

Judy LaMarre reported that Route 15 bus stop on Livermore Avenue near Walmart needs a light.

Sue Tuite, Susan O'Neill and Judy LaMarre reported that Dial-A-Ride was late picking them up for the TAAC meeting and as a result they were late. Victor Carranza (Big Star Transit) apologized and responded that this was due to a vehicle break-down and school starting, which created more traffic.
